Required Documents for Student VISA (Short Term Visa up to 90 days)

	1 recent passport sized colour photograph (not older than 6 months)	
	Passport not older than 10 years and photocopy of the same	
	Passport's validity minimum 90 days from the date of expiry of the requested visa	
	Previous Schengen visas, if applicable	
	Two blank pages, if possible, consecutive.	
	Photocopy of valid Bahraini CPR	
	Photocopy of valid National GCC nationality, if applicable	
	Photocopy of valid Residence Permit for non GCC nationals (minimum validity of 3 months from the return date)	
	Local sponsor's letter, if applicable	
	<u>Proof of financial means:</u> Original personal or parents' bank statement of the last 3 months (with original bank stamp)	
	<u>For existing students:</u> Official letter of enrolment from the local school/college/university, specifying the details of the course and the purpose of travel, detailing the affiliate Schengen school/college/university the applicant intends to travel to, with the respective travel and return dates to Bahrain.	
	Acceptance/admission letter from the School/University/College stating the following details: <ol style="list-style-type: none"> 1. Duration of course 2. Type of course (subjects undertaken) 3. Teaching language of study (English or Italian) <ul style="list-style-type: none"> - In case of teaching language being Italian, please provide proof of basic certificate of knowledge of Italian i.e. Language certificate. 4. Receipt proof, deposit or full payment of the course fee from the University/College. 5. Proof of accommodation, whether on campus or alternate lodging (i.e. hotel booking. Dates must correspond exactly to the flight booking). 	
	Return airline reservation	
	Medical travel insurance: <ul style="list-style-type: none"> - Valid for the entire Schengen territory, with a minimum of Euro 30,000 cover. - Inclusive of repatriation flight 	
	Note: Students must be over 14 years of age. In case of a minor travelling unaccompanied, we require: <ul style="list-style-type: none"> - Application signed by both parents/legal guardian - No objection/Parental authority form duly completed and signed. Available on our website. - Photocopy of birth certificate with the father and mother's name clearly visible - Photocopy of passport of mother and father, with the signature clearly visible.
